In continuation of our earlier intimation dated 9^{th} June, 2025 informing about Initiation of Legal Proceedings before the Hon'ble Bombay High Court in compliance with the Direction of the Hon'ble Delhi High Court in W.P.(C) 4633/2025 & CM APPL. 21406/2025, we hereby inform you that:

The BSE issued a notice dated 5th August, 2025, informing that the securities of the Company have been moved out of the Graded Surveillance Measure (GSM-Stage 4) w.e.f., 6th August, 2025. Accordingly, after careful review and deliberation, the management has unanimously decided to withdraw the Writ Petition No. 2966 of 2025 filed against the BSE before the Hon'ble Bombay High Court.

We further inform you that the Hon'ble Bombay High Court, at the hearing held on 17th September 2025, granted permission to withdraw the petition and accordingly passed an order to that effect. A copy of the said order is enclosed herewith and marked as "Annexure-A."
